**Competition surface:**

The size of the competition surface is 14 m x 16 m in all of the categories above.

**Registration:**

The amount of participants from one club is not limited. The registration for the competition is open 9.10.-17.11.2023. The registration will happen with a Google Forms document. HAC will confirm the registration via email. The changes in the registration are possible with a 50euro per person extra fee.

The extra category fee 5euros/per person /per category is charged for all the participants who will take part in more than one category or groupstunt. The extra category fee applies also to coaches, team leaders and spotters.

All of the registered participants have to have their own insurance, which covers competitive cheerleading. The organizer is not covering the non insured athletes or other participants. The organizer will send a invoice after the registration has closed. Paid invoice is a demand for participation.

### **Rules and regulations**

This competition follows ECU:n / SCL rules and regulations, except the size limitations. In all of the categories the competitors will get a feedback through a ECU scoringsheet.

### **Judges**

The competition is judged by experiences judges.

### **Registration**

The registration will happen on the competition day starting at 12.00 in the registration office. One representative of the competitors will have to participate to the registration (coach, teamleader) and confirm that the competitors are the once as registered to the competition. The representative will receive the amount of armbands that the team has registered, after confirming the participants with their signature. The participants have to wear the armbands when moving in the competition venue at all times.

### **Meals**

The organizer wont be offering meals to the competitors during the competition. There is a small cafeteria at the venue where the competitors can buy themselves snacks during the day.

### **Warmup**

The registration fee will include a possibility to warmup at HAC Training Center, in Ristipellontie 14, 00390 Helsinki. The warmup area is booked for the competitors

from 10.00 to 14.00. We hope for cooperation between the competitors during the warmup since the possibilities to play music are limited in the venue, please notice the others while warming up.
